INTRODUCTION

Planting season is in full swing and thankfully, many producers were able to take advantage of dry windows in March and the first week of April. Most of the corn has already been planted and some producers have started planting rice as well. With the next dry window, I expect many will begin planting soybeans as well.

The 2021 USDA planting intentions were released and with corn and soybean prices remaining strong, Mississippi row crop producers are planning to increase their corn and soybean acreage with a slight reduction in cotton, rice, and hay acreage.

Every growing season presents its own challenges to be overcome, and I'm sure this one will be no different. Here at the MSU Extension Service it is our job to provide support and resources as they are needed. If you have any questions, please don't hesitate to pick up the phone or stop by the office.

CORONAVIRUS FOOD ASSISTANCE PROGRAM

USDA is implementing updates to the Coronavirus Food Assistance Program (CFAP) for producers of agricultural commodities marketed in 2020 who faced market disruptions due to COVID-19. USDA's Farm Service Agency (FSA) reopened sign-up for CFAP 2 for at least **60 days** beginning on **April 5, 2021**. CFAP updates also include:

• An increase in CFAP 1 payment rates for cattle
